1. Executive Summary

XDCPeacock (ticker: XDCP) is the premier community-driven meme token on the XDC Network, engineered to deliver both high-velocity fun and institutional-grade trust. Leveraging XDC's sub-cent transaction fees and 2-second finality, XDCPeacock combines:

• Ultra-Low Fees & Instant Settlement — Typical transactions cost less than 0.01 XDC and confirm in under 2 seconds. • Locked Liquidity Assurance — 40% of the total supply is seeded into our XSwap pool and locked for a minimum of six months, safeguarding against rug-pull scenarios. • Transparent, Balanced Tokenomics — A total supply of 50 billion XDCP is allocated across presale participants, ongoing ecosystem incentives, marketing, and strategic reserves. • Vibrant, Rewarding Community Engagement — From daily meme-NFT drops to tiered staking rewards in our partner pools, XDCPeacock fosters active participation and shared ownership.

By marrying the cultural dynamism of meme coins with rigorous on-chain security and clear governance, XDCPeacock aims to become the flagship meme asset of the XDC ecosystem. Join us and soar with the flock.

2. Introduction & Problem Statement

Meme-based tokens have revolutionized community engagement in DeFi, yet too many projects suffer from:

1. Prohibitive Network Costs — On high-gas chains like Ethereum, everyday meme trading can incur tens of dollars in fees, disenfranchising smaller participants. 2. Rug-Pull Vulnerabilities — Projects that fail to lock liquidity or obfuscate tokenomics often leave holders stranded when developers withdraw funds. 3. Opaque Economics & Roadmaps — Missing details around token distribution, vesting schedules, or treasury management erode community confidence.

The XDC Network addresses fee and speed constraints but has lacked a unifying, "go-to" meme token. XDCPeacock fills that gap by offering a purpose-built XRC-20 asset that is as reliable as it is fun, providing a clear, fully-audited framework and a roadmap aligned with community governance.

3. The XDCPeacock Solution

Core Features: - XRC-20 Standard Compliance — XDCPeacock is an XRC-20 token, compatible with all EVM tools and wallets on XDC. - Rigorous Liquidity Lock — 40% of tokens are paired with XDC in an XSwap pool; LP tokens are locked via our integrated service for at least six months. - Deflationary Mechanics (Optional Upgrade) — A configurable 0.5% burn on each transaction can be activated via governance to reward long-term holders. - Fair-Launch Presale — Presale contributions are capped per address and distributed directly after presale close—no hidden mints, no pre-allocations.


Unique Value Propositions: 1. Daily Meme-NFT Drops — Holders receive exclusive, limited-edition NFT memes each week, minted and airdropped automatically. 2. Partnered Staking Pools — XDCPeacock will launch yield-bearing pools on leading XDC DeFi platforms, enabling holders to earn passive rewards. 3. On-Chain Governance — Token-weighted proposals let the community allocate treasury funds, approve new partnerships, and vote on feature releases.

4. Technical Architecture

XDCPeacock utilizes battle-tested contract patterns and industry-standard tooling:

- Smart Contract Design: Built in Solidity and deployed via XDC.sale, our XRC-20 contract exposes only the standard functions plus an optional pause control for emergency security. Constructor parameters enforce a fixed max supply of 50 billion tokens and prevent further minting. - Audit & Verification: Undergoing a comprehensive security audit with CertiK. Upon approval, the full report will be publicly available on XDCScan. Contract source code is verified on XDCScan, ensuring full transparency into the token logic. - Infrastructure & Oracles: Price feeds and analytics are supported via Chainlink oracles (pending integration) for future staking and governance modules. Bootstrap scripts automate liquidity provisioning on XSwap and LP-token locking.
